



ONLINE SPANISH-ENGLISH BILINGUAL AUTHORIZATION FOR IN-SERVICE TEACHERS

Santa Clara University is pleased to offer an innovative, online Bilingual Authorization program for in-service, TK-12 teachers through the Center for Professional Development in the School of Education and Counseling Psychology. Grounded in our Jesuit values for social justice, care for the whole person, and meeting the needs of our community, our Bilingual Authorization program prioritizes preparing TK-12 teachers with a deep commitment to address equity and opportunity gaps for students, to understand the importance of maintaining home language while supporting English learning, and to bring a strengths- and asset-based framework to bilingual education.

Our program prepares bilingual teachers that already hold a preliminary or clear teaching credential to add a CA Bilingual Authorization. This Bilingual Authorization allows the holder to provide content instruction to English Learners in English and Spanish across a range of school settings including public, charter, private, and Catholic schools. The program allows in-service teachers to sharpen their Spanish language skills and cultural knowledge about Spanish-speakers as classes are conducted in Spanish. The equity and social justice lens that guides the program provides a ripe context to discuss and challenge current models of bilingual education. Teachers complete the four course program through a combination of synchronous class sessions (via Zoom) and asynchronous readings, lessons, and fieldwork.

IN-SERVICE TEACHER BILINGUAL AUTHORIZATION

- We offer two programs: **Summer Cohort** (6-month program launching in June) and **Fall Cohort** (9-month program launching in September)
- In-Service teachers enroll in 4 content-rich courses (Bilingual Foundations, Latinx Language & Culture, Bilingual Methods, Bilingual Seminar) taught in Spanish
- In-Service teachers apply what they are learning with students within their classroom and receive feedback from Bilingual program faculty
- After completing the program, In-Service teachers are recommended to the California Commission on Teacher Credentialing to receive the Bilingual Authorization add-on certification

ADMISSIONS REQUIREMENTS FOR BILINGUAL AUTHORIZATION

- Online completed application (**No application fee**)
Proof of applicant’s valid Preliminary or Clear Teaching Credential (Only California Applicants can be recommended to the CTC)
- Local Language Competency Assessment (required for Admission)
- Verification of Employment and Employer Support for Fieldwork (Form is on the online application)
- Passing score on CSET LOTE-Spanish III not required for admission, but must be passed and submitted prior to completing the Bilingual Authorization

Thank you for your interest in the Online Inservice Bilingual Authorization Program through the Center for Professional Development at Santa Clara University's School of Education and Counseling Psychology.

The Center for Professional Development (CPD) offers an Online, In-Service Bilingual Authorization Program that allows teachers who currently hold a single or multiple-subject teaching credential in California to add the Bilingual Authorization. We have a 6-month and 9-month program, completely online. Some highlights of our program are as follows:

SELECT THE APPROPRIATE APPLICATION

1. Go to <https://slate.scu.edu/apply/> and create an account. Make sure you remember your username and password.

5. You will see our generic application portal. It is very important that you select the correct application in order to generate the appropriate requirements.

Make sure that you complete all the four sections and that you upload your materials. Specific instructions per section are given below:

The Professional Development Bilingual Authorization Application

There are 4 sections to the Professional Development Bilingual Authorization application:

1. Program of Study
2. Personal Background
3. Academic History
4. Bilingual Supplemental

On the Program of Study page select the following:

- Degree Level: Non-Degree
- Program of Study: Professional Development Bilingual Non-Degree

Application Requirements

1. Complete the online application.

Note: The application fee is waived upon submission.
Make sure you list all the post-secondary institutions that you attended in the Academic History section.

2. Proof of applicant's valid Preliminary or Clear Teaching Credential

California Teachers: Upload a screenshot of your credential from the **Search for an Educator CTC website**. Must have a valid California or Preliminary or Clear Teaching Credential to be recommended to CTC for the California Bilingual Authorization.

Out of State Teachers: You can apply and be admitted to our program, but SCU can only recommend the Bilingual Authorization to be added to a valid California teacher credential to CTC. Unless you already have a valid

Preliminary or Clear California Teacher Credential by the time you are admitted, you will not be able to be recommended retroactively to CTC at the end of the program.

3. Verification of Employment and Employer Support for Fieldwork

4. Local Language Competency Assessment

Program Requirement for Credential Recommendation

1. Passing score on CSET LOTE III-Spanish.

Note: This is not required for admission, but must be passed and submitted prior to completing the Professional Development Online Inservice Bilingual Authorization program.

SCU cannot provide the Bilingual Authorization Recommendation to CTC without a passing score on the CSET LOTE III-Spanish.

Deadlines

Fall Deadline: August 18

Once You Have Applied

Once you submit your application, you will receive an email confirmation that your application has been successfully submitted to Santa Clara University.

Applications are processed within 2-4 weeks of receipt. If your application is incomplete and missing any documentation required, it shall remain unprocessed until all documents have been received.

Once a decision has been made on a Bilingual Professional Development application, you will be notified via your email address with a link to view your final admissions decision.
