INSURANCE VERIFICATION FOR STUDENT TRAVEL ABROAD

INSTRUCTIONS: This mandatory form must be completed by all students participating in SCU university-sponsored international travel. Students must read and verify each type of insurance coverage they will maintain during the travel dates of the SCU program abroad, both en route and abroad.

SUMMARY: All students are required to maintain insurance coverage during university-sponsored international travel. There are five types of coverage students may carry while abroad, see below. Students may be covered by multiple insurance policies while abroad and it is important for students to understand what coverage they have, or what coverage they may need to purchase to insure sufficient coverage.

OVERVIEW OF STUDENT INSURANCE POLICIES FOR TRAVEL ABROAD

1. SCU On-Campus Policy and/or Personal/Family Policy (All students) All Santa Clara students are required to maintain coverage equal to or greater than the [on-campus Student Health Insurance Plan policy \(SHIP\)](#) even while they are abroad. Students are automatically enrolled into SHIP unless they are approved for a waiver through [SCU's Student Health, Counseling, and Well-Being's health insurance waiver process](#).

2. Mandatory SCU Travel Insurance through CHUBB & International Travel Assistance through International SOS

All Santa Clara University international travelers are covered by the University's policy for emergency medical care, travel assistance, evacuation and repatriation of remains. [Policy information can be found on the Global Engagement website](#). This policy does not provide sufficient coverage alone. *It is not possible to waive this.*

The following options are only for undergraduate SCU Study Abroad students:

3. Mandatory National Healthcare Coverage for undergraduate SCU Study Abroad participants on programs in the following countries (only): 1) Australia; 2) England; 3) Scotland; 4) Japan, 5) Sweden. This insurance provides student coverage for students enrolled at universities in these countries while inside the country. It does not provide coverage en route to the country, when traveling outside the country, or outside the dates of the academic program. *It is not possible to waive this.*

4. Mandatory Insurance through Program Providers for participants on undergraduate SCU Study Abroad programs through the providers below (only). *It is not possible to waive this.* Programs include:
